There is not enough water in the reservoir to allow the option of shutting the water off for a period of time to conserve and then restarting. If the system is shut down to conserve water it will not be able to be brought back online until the amount of water reaches a safe level to avoid any potential damage to town infrastructure.

Be it resolved, that due to the severity of the low level of water in our town surface ground water reservoir council authorizes the shut-down of the water system to the town to avoid damage to town infrastructure and conserve water until it reaches a level that allows the system to function properly.
