- ✓ Installation of Merry-go-round for St. Thomas School Letter from Principal. Council decided to ask ICR building supplies for a quote. The town doesn't have the resources to install it. Council will ask the school for an agreement stating that if we invest in installing this equipment, and should the school close, the equipment would stay on the playground.
- ✓ Waste disposal containers around town ie: By Tourist Chalet & Town office. Council decided to defer decision until the spring.
- ✓ Stephenville, Kippen's, Port au Port Search & Rescue. Mr. Gerry Clark contacted Mayor Cashin and requested financial assistance in building a slipway on the Gravel's Beach to launch their rescue boat. Council said No to this. We are already donating to this organization and the location of the proposed slipway is not in our town.
- ✓ Landscaping Policy. Clerk will continue to gather information from other communities.

- ✓ Gravel's Beach Clean-up Council received a letter from Mary McCormack thanking them for delaying the clean-up of the beach until the nesting birds leave in mid-August. Port au Port West, Aguathuna & Felix Cove will cost share this with us. Council will wait for all quotes to do this work.
- ✓ Reservoir Liner Tender awarded to Marine Contractor's Limited. Town is on "Conserve Water" and Clerk will contact St. Thomas Aquinas School and ask that they conserve as much as possible by using bottled water and ensuring that urinals are not automatically flushing.
- ✓ Generators Clerk will contact John Lambe (Canadian Coast Guard) and let him know that we would like to have the generator made ready to send to us asap. We want to have it installed before frost.
